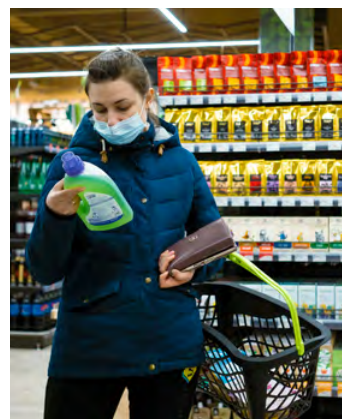
— is a family company, which was founded in 1998, in Krasnodar City. Our supermarkets are located in the Krasnodar Region.

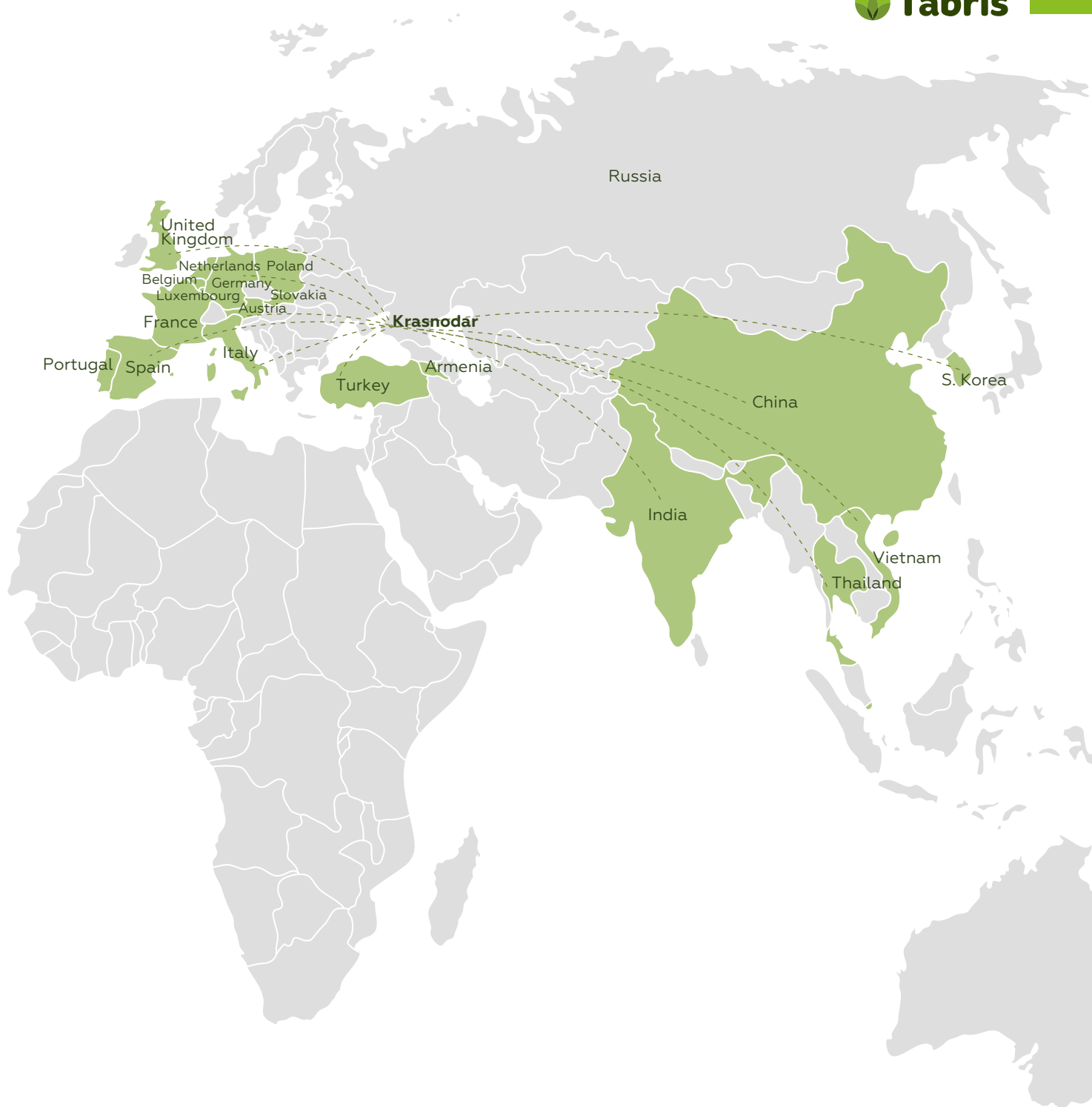

Since 2014, our network has been directly importing products from different countries around the world.

There are no restrictions on the import of consumer goods that we buy for sale in Russia this period of time.



FAQ

How do the sanctions affect payment?

Our bank servicing foreign exchange contracts is Raiffeisenbank (a member of the Austrian banking group Raiffeisen Bank International), Which isn't under sanctions, and continues to work regularly despite restrictions on a number of banks.

Therefore, we can pay for Goods without any restrictions.

Is it possible to export goods to Russia?

There are no prohibitions on the export of food and non-food consumer goods to Russia by the European Union and other countries on August 1, 2022.

Will the goods be allowed through at the borders? How is the logistics situation?

Since 2014 (when we started importing goods and making international purchases) and until now, we deliver all goods via the large logistics company that has many partners in different countries.

This company provides all logistics procedures, including insurance of Goods. The cargoes consisting of groceries and consumer goods are delivered to Russia without restrictions.

We appreciate working with each partner and, despite the difficult political and economic situation and we want and we are ready to continue working, supporting the assortment of our supermarkets.



For us it is very important that each of those **37,000 people who come to our supermarkets every day** can buy everything they need for themselves and their loved ones.
